

ABOVE GROUND LINER SAFETY INFORMATION

DO NOT DIVE OR JUMP INTO YOUR POOL!

DIVING AND JUMPING IS STRICTLY FORBIDDEN AND CAN CAUSE SERIOUS INJURY, PARALYSIS OR DEATH.

IMPORTANT: SHALLOW WATER

This swimming pool does not have sufficient depth for diving. Do not dive. Do not allow others to dive into this swimming pool. Diving is dangerous. Prevent accidents by prohibiting horseplay and unnecessary roughness in the pool or the pool area.

SAFETY INFORMATION

- The homeowner is responsible to install all safety labels. Safety labels shall be placed above the water line, never covered and always visible from any potential entry points of the pool. Also, make sure to install safety labels at all access points of your yard.
- Adult supervision is always necessary. Never take your eyes off children
 or swimmers in the water or near the pool. Designate an adult pool watcher.
 Make sure that you or your pool watcher are able to intervene in less then
 10 seconds to save a life or avoid injury.
- · Do not swim during thunder, electrical or wind storms.
- Keep rescue equipment such as life rings and reaching poles etc, in a prominent area by the pool at all times. Please consult your municipality to get a rescue equipment list.
- An emergency phone number such as: nearest available police, fire, ambulance and/or rescue unit, must be visible from pool area. A functioning fixed or cellular phone must be reachable immediately.
- It is important that all users be able to see the bottom of the pool. Foggy
 water must be cleared up before entering the pool. At night, sufficient
 lighting must be available. It is the homeowner sole responsibility to
 provide adequate lighting for pool bottom, safety labels and walkways,
 which exceeds minimum standards of the IES of North America.
- · Never swim alone, under the influence of drugs or alcohol, tired or ill.
- All accessories: the homeowner must follow the manufacturer's instructions and safety warnings.

SAFETY LABELS

Install safety labels (supplied with the liner) inside the pool so that at least one label is visible no matter where the bather stands.

WARRANTY

Ocean warrants this liner to be free of defects in our workmanship. Examine your liner carefully before installing. Handle your liner carefully during inspection and installation, as the manufacturer is not responsible for tears or punctures caused by improper handling. A 4" (10 cm) cove must be put inside around

the base of wall to protect the liner from coming into contact with the pool frame. Refer to Figure A on reverse.

Ocean's warranty regarding pool liner manufacturing defects enters into effect on the purchase date of the liner as indicated on the purchase invoice and expires at the end of the 10th year following the purchase date. Replacement under the warranty is as follows:

Ocean will not be responsible for any labor charges, cost of lost water or chemicals, or any other damages. This warranty is void if pool is emptied. This warranty is not transferrable and applies only to the original retail purchaser.

Damage resulting from acts of God or force majeure, including, but not limited to, lightning, flooding, the overflow of moving or stationary bodies of water, earthquakes, shifting ground or exceptional climatic conditions such as a deep freeze or heavy downpour and is not covered under warranty.

Any return of merchandise under the terms of the warranty must be authorized in advance by Ocean, and returned freight prepaid.

The customer must notify Ocean promptly in writing of any liner related anomalies or particularities that could indicate a possible manufacturing defect and provide a purchase receipt with a sufficiently detailed description and supporting photos of the observed anomaly or particularity, as well as with the identification seal pasted to the back of the liner. Such notification must be received by Ocean within two weeks following the appearance of the observed anomaly or particularity. Any undue notification delays will void warranty or reduce its scope. Upon receiving the notification, a technician from the warranty department will review the situation and will inform the customer whether the liner has an installation defect or not, and, if applicable, will inform the customer of any repairs to be made to liner to correct the manufacturing defect.
